### SIGNIFICANT ACCOUNTING POLICIES AND ACCOMPANYING NOTES TO THE FINANCIAL STATEMENTS

(1) Corporate Information
Harikanta Overseas Private Limited is a Private Limited company and incorporated under the provisions of the Companies Act, 2013. The company is engaged in the business of Manufacturing of Textile Fabrics and other textile related activites.

(2) Basis of Accounting

All incomes and expenditures are accounted on accrual basis. Sales and purchases are accounted for exclusive of tax, duties, cess, etc. and are net of goods return, discount, etc.

### (5) Retirement Benefits

The company has not incurred any expenditure pertaining to retirement benefits for the year under consideration.

### (6) Borrowing Cost

Borrowing costs that are attributable to the acquisition or construction of the qualifying assets and incurred till the date when they are first put to use are capitalized as part of the cost of such assets. All other borrowing costs are charged to the profit & Loss account.

### (7) Segment Reporting

The company has only one business segment and geographical segment. Therefore, there is no separate reportable segment as per AS-17
"Segment Reporting" issued by Institute of Chartered Accountants of India.

### (8) Taxation

Provision for tax liability comprises of current tax.
